
1. I have reviewed the enclosed Separation packet on, SSG Lewis T. Foutch, 416-35-7907, D Company, 2nd Battalion, 160th Special Operations Aviation Regiment (Airborne), Fort Campbell, Kentucky 42223.
2. After careful consideration of all matters, I direct this Soldier be:
  - ( ) Retained.
  - ( ) Retained and rehabilitatively transferred to another unit as directed by the G-1/MPD.
  - ( ) Separated, but that the separation be suspended for a period of \_\_\_\_\_ months (not to exceed 12 months).
  - Separated from the Army prior to the expiration of current term of service.
3. I direct that this Soldier's service be characterized as:
  - General under honorable conditions.
  - ( ) Recommend Honorable discharge, and forward to Commander, Headquarters, Fort Campbell, Fort Campbell, Kentucky 42223 for disposition.
4. After considering the need to retain trained personnel in the IRR for mobilization purposes, the positive motivation that full mobilization may have on the Soldier, and the probable maturing effect of the passage of time, I have determined that this Soldier will not be transferred to the IRR.
